Ho Han Leong Calvin is treated under Section 4 of the Securities and Futures Act as having an interest in 364,213,537 Shares, through his (i) 50% interest in TT Properties (Asia) Ltd. ("TTPL"), which holds a 20% interest in First Sponsor Management Limited ("FSML"), which holds a 67.5% interest in First Sponsor Capital Limited ("FSC"), which in turn holds 286,764,270 Shares directly, and (ii) 50% interest in SG Investments Pte. Ltd. ("SGI"), which holds a 44% interest in Tai Tak Estates Sendirian Berhad ("TTESB"), which holds a 100% interest in Tai Tak Industries Pte. Ltd. ("TTIP"), which in turn holds a 100% interest in Tai Tak Asia Properties Limited ("TTAPL"). TTAPL holds 65,173,697 Shares directly; and (i) a 32.5% interest in FSC, which in turn holds 286,764,270 Shares directly, and (ii) a 100% interest in Chengdu Tianfu Properties Ltd. ("CDTF"), which in turn holds 12,275,570 Shares directly.

Ho Han Leong Calvin is treated under Section 4 of the Securities and Futures Act as having an interest in an aggregate of S\$66,782,398.80 in principal amount of series 2 convertible securities, through his 50% interest in SGI, which holds a 44% interest in TTESB, which holds a 100% interest in TTIP, which in turn holds a 100% interest in TTAPL.
