Millennium & Copthorne Hotels Limited ("M&C") has a deemed interest in 326,247,596 ordinary shares in FSGL by virtue of the provisions of Section 4 of the Securities and Futures Act, Chapter 289 ("SFA"). On 19 November 2019, Agapier, an indirect wholly-owned subsidiary of City Developments Limited ("CDL"), successfully privatised M&C through a compulsory acquisition exercise. Accordingly, Agapier has a deemed interest in 326,247,596 ordinary shares in FSGL by virtue of the provisions of Section 4 of the SFA.

Accordingly, Agapier has a deemed interest in 326,247,596 ordinary shares in FSGL by virtue of the provisions of Section 4 of the SFA, through (i) 289,844,938 ordinary shares held by Republic Hotels & Resorts Limited ("RHRL"); and (ii) 36,402,658 ordinary shares held by M&C Hospitality International Limited ("MCHIL"). RHRL and MCHIL are both subsidiaries of M&C.
