While Form C will be attached to the announcement template, it will not be disseminated to the public and is made available only to the Monetary Authority of Singapore (the "Authority").

Ho Han Leong Calvin is treated under Section 4 of the Securities and Futures Act as having an interest in 87,330,829 W240530 warrants and 103,896,152 W290321 warrants, through his (i) 50% interest in TT Properties (Asia) Ltd, which holds a 20% interest in First Sponsor Management Limited, which holds a 67.5% interest in First Sponsor Capital Limited ("FSCL"), which in turn holds 28,676,427 W240530 warrants and 71,691,067 W290321 warrants directly, and (ii) 50% interest in SG Investments Pte. Ltd., which holds a 44% interest in Tai Tak Estates Sendirian Berhad, which holds a 100% interest in Tai Tak Industries Pte Ltd, which holds a 100% interest in Tai Tak Asia Properties Ltd ("TTAPL"). TTAPL has (i) a direct interest in 56,794,221 W240530 warrants and 28,862,637 W290321 warrants (including 28,750,000 W290321 warrants held in the name of Citibank Nominees Singapore Pte Ltd.), and (ii) a 32.5% interest in FSCL, which holds 28,676,427 W240530 warrants and 71,691,067 W290321 warrants directly, and (iii) a 100% interest in Chengdu Tianfu Properties Ltd, which has a direct interest in 1,860,181 W240530 warrants and 3,342,448 W290321 warrants held in the name of DBS Vickers Securities (S) Pte Ltd.
