CORRIGENDUM

The board of directors (the "Board") of First Sponsor Group Limited (the "Company") refers to (a) the Company's Annual Report for the financial year ended 31 December 2024 released on 4 April 2025 (the "FY2024 Annual Report"); (b) the financial statements for the financial year ended 31 December 2024 released on 25 February 2025 (the "FY2024 Financial Statements"); and (c) the investor presentation released on 25 February 2025 (the "Investor Presentation") (collectively, the "Announcements").

Unless otherwise defined herein or the context otherwise requires, all capitalised terms used in this announcement shall bear the same meanings ascribed to them in the Announcements.

The Company wishes to inform that the basic earnings per share for half year ended 31 December 2024 and full year ended 31 December 2024 have been restated to 6.92 cents and 8.02 cents respectively, instead of the previously reported 7.19 cents and 8.29 cents respectively. The restated basic earnings per share has been computed based on the profit attributable to ordinary shareholders instead of the profit attributable to ordinary shareholders and PCCS holders.

As a result, the Company wishes to further inform that:

- (a) The table under item 6 on page 33 of the FY2024 Financial Statements should be corrected as follows (with amendments in bold, underline and deletions in strikethrough):
- Earnings per ordinary share of the group for the current financial period reported on and the corresponding period of the immediately preceding financial year, after deducting any provision for preference dividends.
